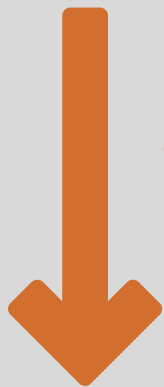
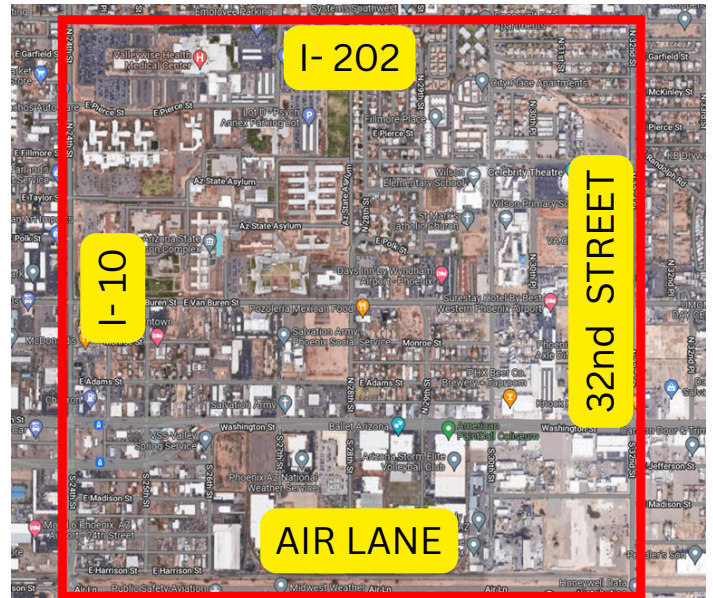
EXPANSION TO THE 24 SKY HARBOR BUSINESS ALLIANCE

This program was successfully piloted and launched on Northern Avenue from I-17 to 17th Drive. Within the first 4 months, calls for service from the area went DOWN 32%. Now the work is being done to expand the program to other areas in the city.

PROGRAM BENEFITS INCLUDE:

- Larger footprint of crime suppression
- Regular addiction resources/outreach
- Tax deductible program contribution
- Weekly bulk trash pick up
- Support for property improvements
- A DISPATCH PHONE # FOR IMMEDIATE SUPPORT
- A single officer in a fully marked vehicle to patrol the area, **10 hours per night/5 nights a week (Monday through Friday) and 24 hours per day/night, 2 day/nights a week (Saturday and Sunday) for 12 months.**
- Sharing the price, reduces the cost for each participating business

24 Sky Harbor Business Alliance serves the businesses between the 202 freeway on the north, and Air Lane on the south, 32nd Street on the east, and I-10 on the west.



Collaborating our efforts and resources will significantly improve the safety of the area!

- 31.76% Calls for Service
- 25.44% Property Crimes
- 16.67% Violent Crimes

ESTIMATED COST CALCULATION:

TOTAL COST for all 5 elements of the program for 24SHBA: \$277,320.00
divided by 30 participating business =
\$9,244/year or \$770.33/month or \$1.81/hr

Participation levels have been created so that every business can participate as their budget allows.

Collaborating our efforts and resources to provide addiction resources and social services, while deterring drug related crimes from the community.

PROGRAM DELIVERABLES INCLUDE:

- Private security to patrol the community 10 hours per night/5 nights a week (Monday through Friday) and 24 hours per day/night, 2 day/nights a week (Saturday and Sunday) for 12 months.
- A comprehensive list of property owners, managers, businesses and business managers
- Monitoring and case management of problematic bus stops in partnership with Phoenix PD
- Identified priority areas for outreach and services in partnership with the City of Phx
- Continuous monitoring and case management to assure properties in the area are maintained to city codes
- Community improvement project as identified by the program participants
- Bulk trash removal of shopping carts and bulk trash
